WHAT IS ENDODONTICS?

Endodontics is a field that specializes in the diagnosis, prevention and treatment of diseases in the pulp or the soft tissue inside your tooth. An endodontist is a dentist who has completed an additional two years of intensive study after obtaining a dental degree. An endodontist practices endodontics exclusively. A Board Certified (Diplomate) endodontist is one who has taken and passed a rigorous additional series of exams administered by the American Board of Endodontics, the certifying board for our specialty recognized by the American Dental Association.

MISSION

Our mission is simple: to provide you with the highest standard of care obtainable anywhere.

TREATMENT SEQUENCE

With a thorough examination, we will establish a diagnosis and explain to you the nature of your endodontic problem (if you have one) and plan an appropriate treatment sequence. We will take multi-view x-rays and begin treatment immediately if your discomfort level warrants it. We will perform needed conventional endodontic treatment or surgical treatment when necessary. Unless your family dentist notifies us, you will re-visit your family dentist for the final restoration procedures (crown, bridge, etc.). We will re-examine you periodically until your tooth is completely healed.

HONORING APPOINTMENTS

We recognize that your time is a precious asset. For that reason, no other patients will be scheduled during your appointment. Please be punctual so that we can be on time for you. Our office sees only a limited number of patients; it is our goal to eliminate any delays.

STERILIZATION PROCEDURES

Under no circumstances will previously used endodontic instruments be utilized in your treatment. Basic hand instruments and handpieces undergo a sterilization procedure that far exceeds FDA, NIH or OSHA recommendations.

FEES

The fee for your endodontic treatment will be based on the extent of treatment. During your first visit we will discuss the probable number of visits, their length, and the fees involved. Endodontic fees usually range from \$900 to \$1,500. It is our policy that your care be paid for at the time of treatment. Because of the unique nature of our retreatment practice and the specialized types of cases we treat, it is not possible for us to accept insurance in lieu of payment. We will, however, provide you with all the information required by your insurance carrier so that you may obtain any reimbursements due to you.

PRIVACY POLICY

This privacy notice discloses the privacy practices for SJS Endodontics & Microsurgery. This privacy notice applies solely to information collected by this practice. It will notify you of the following:

Security - We take precautions to protect your information. When you submit sensitive information, your information is protected both online and offline. Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted in a secure way.
